

# Additional information

## Ickniel Court

We want to ensure that you have all the information you need prior to an assessment being arranged, so we have outlined below some additional information that you may wish to know.

<p><b>1</b></p>	<p><b>Trial period</b></p> <p>The first four weeks of your stay will be a trial period, during which you can end this agreement for any reason by giving us at least one weeks' notice in writing to the Home Manager.</p> <p>After the end of the trial period, you can end this.</p>	<p><b>2</b></p>	<p><b>Ending contract</b></p> <p>If you decide that you would like to end your contract with us and move out of the home, you may do so at any time, subject to giving 28 days notice in writing to the manager of the home. Fees will be payable in full during the notice period.</p>
<p><b>3</b></p>	<p><b>Payments</b></p> <p>A deposit of £2,000 and the pro rata fees for the first month are payable in advance of admission. Your first invoice will be issued on the 1st of the following month for the whole of that month. We will collect the Direct Debit for this after 10 working days. Any balance from the deposit or fees paid in advance will be refunded following death or discharge.</p>		
<p><b>4</b></p>	<p><b>Changes to self-funding arrangements</b></p> <p>If your circumstances change and you decide to apply for funding from the local authority in the future, the conditions of the contract remain unchanged. Where a difference exists between the agreed cost and the total purchase cost agreed by the local authority, a top up contribution would be required from you. We advise you to seek assistance from the local authority at least four months before you expect your funds to reduce to the threshold in order to allow time for them to complete their processes.</p> <p>If you become eligible for continuing healthcare from the NHS, the full amount will be payable as your weekly fee.</p> <p>We will always use our best endeavours to reach agreement with appropriate authorities to enable you to remain in our care providing the home continues to meet your needs.</p> <p>In the event it is necessary for The Fremantle Trust to terminate the contract and end your residence, not less than 28 days notice would be given unless exceptional circumstances apply. We reserve the right to give notice if you fail to pay your care fees or if your needs change to such an extent that we can no longer provide you with safe care.</p>
